

THE LICENSING ACT 2003 – TABLE OF FEES

Fees for the processing of applications are set centrally by Government and are not controlled by Aylesbury Vale District Council.

The following information is a summary of our interpretation of the relevant documents. It is not a full and authoritative statement of the law and does not constitute professional or legal advice. Applicants may wish to consult the actual regulations, namely The Licensing Act (Transitional Conversions Fees) Order 2005 (SI80 2005), The Licensing Act 2003 (Fees) Regulations 2005 (SI 79 2005) and The Licensing Act 2003 (Fees) (Amendment) Regulations 2005 for a full explanation of definitions and exemptions or to seek legal advice before calculating the fee due.

Major application fees are set on a sliding scale based on the non domestic rateable value (NDRV) of the premises concerned, whilst minor applications carry set fees.

Cheques for all applications are payable to Aylesbury Vale District Council.

* To find out the Non Domestic Rateable Value (NDVR) for your premises, you can search for your rateable value on the valuation list at the Government's Valuation Office Agency's website http://www.voa.gov.uk/business_rates/index.htm.main or you can telephone Aylesbury Vale District Council's Business Rates Department on 01296 585096. Please note that from 1 April 2005 new rates apply, so for any applications made after this date you will need to use the new rateable value. Where the premises form part of a hereditament or comprise two or more hereditaments you should use the hereditament with the highest rateable value.

** The higher multiplier fee is payable where Band D or E premises are used exclusively or primarily for consumption of alcohol on the premises. So, it does not apply to off-licences or registered clubs.

*** For a variation submitted after the conversion application a higher fee is payable and the multiplier again applies to premises in Band D or E used exclusively or primarily for consumption of alcohol on the premises.

**** The annual fee is payable on the anniversary of the grant of the licence, and again, the multiplier applies to Band D or E premises.

An additional fee also has to be paid for premises with a capacity of over 5000, or for a variation which seeks to increase the capacity over 5000. On top of this an additional annual fee is payable for such premises, UNLESS the premises is a building which has been constructed or adapted for the purpose of the licensable activity (see para 4(5) of S1 79 or S1 80 2005 for complete definition of exemptions).
